<u>SSPO industry Code of Good Practice sea lice treatment threshold – 0.5 adult female lice Feb-June</u> and 1.0 adult female lice July-January.

At Clashnessie between weeks 1 and week 40 (after which the site was finally harvested out and fallow) the average weekly declared count of adult female lice per fish was over 5.00 (10 x the Code of Good Practice level for Feb-June and 5 x the Code of Good Practice level for July-Jan).

During eight weeks the declared count was over 6 (Scottish Government's enforcement trigger level), peaking at 10.47 in week 33 (that of 16 August); the average declared count between weeks 31 and 40 was 8.67. In only one week did the sea lice count dip below 2.0 (Scottish Government's reporting threshold level) – in week 26 (1.73).

There are three references to "SG action" – an "advisory letter" in week 19 and two "enforcement notices" in weeks 23 and 36.

Under "mitigation", the only references to treatments relate to the use of Paramove 50 (hydrogen peroxide). Otherwise, remedial action is limited to cleanerfish, occasional "targeted harvesting" and in weeks 33 and 34 "accelerated harvesting". There is also the occasional reference to "new wrasse" and in one instance the introduction of "trained wrasse".

In five of the six final weeks, before harvesting was completed, the company elected not to perform a sea lice count – citing "veterinary advice" or "withdrawal period prior to harvesting". On the one occasion during these six weeks when a count was performed, it was 9.04 (the second highest during the time series); we believe that it is reasonable to conclude that lice levels were similarly high during the other five weeks, given that no mitigation measures (to reduce lice numbers) are referred to on the Scotland's Aquaculture database.
